### Scenario 1: Family Experiencing Debt.

Julie, an administrative worker in the nuclear industry, fell into financial difficulty when her husband's pay stopped due to sickness. TNIBF referred the family to a free debt advice service, cleared their rent arrears, awarded them a short-term regular payment plus a number of one-off grants, giving them time to get back on their feet.

#### Scenario 2: Retired Widower.

Ex-nuclear worker Norman, was widowed and living alone in rented accommodation. Not yet in receipt of his state pension he was just about managing day-to-day financially.

However, when his washing machine broke down he had no savings. TNIBF representatives paid a visit to assess his needs. As a result of this it appeared that he also needed a new bed. He was given a grant for a replacement washing machine and a new bed. Once his state pension commenced Mr Brown became financially better off.

### Scenario 3: Mobility Equipment

Patricia had worked in the nuclear industry many years ago. When, in retirement, the Local Authority was unable to assist with a specialist motor riser recliner chair for her disabled husband, TNIBF awarded a grant to enable the purchase of a chair to improve his quality of life.

- A. TNIBF provides support covering a wide range of situations including disability adaptations, essential home repairs, mobility equipment, household appliances and other one off grants tailored to the individuals needs.
