- Reported that we have now achieved the framework on consultation and negotiation. This is an improved framework which gives the CNPF, with a better commitment as we can now go to Police Arbitration Tribunal, in the event that we cannot reach agreement.

Legal

Following lengthy discussions with It was proposed that, we, as a Federation joined an insurance scheme to cover large financial legal costs. This would cover officers both on and off duty. It would cost £4.50 per month, per member. HS proposed to join the insurance scheme, MN seconded the motion, and this was unanimously accepted. In order to cover part of the costs, DM proposed to raise subscriptions by £2.00 per month, ND seconded

the proposal – Carried unanimously. ND will create and distribute a circular with full details to the membership.(Action 13).

- Discussions took place around the Strategic Objectives within 2011-2014 CNPA Strategic Plans, especially Strategic Objective No3: To implement a programme of workforce modernisation to provide a more flexible and responsive service delivery framework.
